Conditions of Entry

This will be a CONCURRENT event using a BLOCK schedule. If you enter both events offered on the same day, your dog will run twice during your assigned time block and your dog will be able to take a short break between runs. You are free to leave the event site after BOTH runs are completed. NO RUN ORDER will be mailed out, a time block (of an hour) will be assigned. Exhibitors will receive an email with their assigned time block and the final entry listing will be posted to the Desert Fun Bunch FaceBook page (<https://www.facebook.com/DesertFunBunch>) one day prior to the event. **Accommodations will be made for exhibitors if run time(s) conflict with ring times.**

Entries will be limited to 130 dogs per event with two events daily running concurrently from 9:00 am until 4:00 pm.

It is the responsibility of each entrant to be ready with a **catcher** and a **releaser** when their time slot is called. Dogs may run without a collar or with a buckle collar. Collars that are NOT acceptable are as follows: choker collars, training collars, harnesses or any collar with dog tags that are hanging from the collar. Dogs may run muzzled.

Check In & Inspection

Check in/inspection starts 15 minutes prior to the beginning of each time block. Every dog must pass through inspection prior to running in their assigned time block.

Refunds

On day of event and upon initial inspection, any entry found to be lame, unfit to compete or a female in season shall not be allowed to enter and entry fees shall be refunded. No refund for absent dogs.

Prior to event, bitches that come into season may receive a refund with prior notification to event secretary.

Ribbons

Fast CAT Qualifier (must complete the 100-yard run) – Light Blue Ribbon

BCAT, DCAT, FCAT – Blue & Yellow Rosette (It the responsibility of the entrant to notify the event secretary if a title has been achieved. **Rosettes WILL NOT be mailed out.**)

What is FAST CAT?

1. Fast CAT is a timed straight 100-yard dash for dogs.
2. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. Dogs are run individually.
3. Dogs are timed when they complete the 100-yard dash. The time is converted to Miles Per Hour (MPH).
4. MPH = 204.545/Run Time
4. Based on the dog's size at the withers a handicap is applied and points are earned.
 - 18" or greater = Handicap is 1.0
 - 12" up to less than 18" = Handicap is 1.5
 - Under 12" = Handicap is 2.0
5. POINTS = MPH X Handicap
6. Titles are earned at specific point levels. BCAT = 150 points, DCAT = 500 points, FCAT = 1,000 points, FCAT1 = 1,500 points, FCAT2 = 2,000 points

ACCORDING TO AKC RULES (Chapter 16):

- Handlers are not permitted to run down the 100-yard course with a dog during its run nor is the handler permitted to travel down the course to the finish line in preparation for their dog to be released at the start line.
- The Handler (Releaser) cannot recall their dog from the start line after it has completed the course. (Dogs MUST be caught at the finish line by the catcher.)
- Cheering, clapping, calling your dog's name, whistling, and waving your arms from the end of the course or the start area is allowed.
- Noise making devices such as whistles, duck calls, electronic calls or other items of this nature are not permitted.
- The use of toys, treats, flags or other items of this nature are not permitted while the dog is running the 100-yard course, however they may be used after the dog has crossed the finish line to assist in catching the dog.

Fast Coursing Ability Testing

Fast Coursing Ability Tests are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event. (An event is defined by an event number.) Dogs will be inspected prior to any wrapping being applied to the dog. In the opinion of the inspection committee, any entry found to be lame, unfit to compete or a female in season shall not be allowed to enter and entry fees shall be refunded.

The purpose of the AKC Fast CAT event is to provide all dogs and their owners an enjoyable, healthy activity in which they can participate. Dogs run singularly. The dog's time to complete the 100-yard dash is converted into MPH. Dogs earn points based on their handicapped speed. Titles are awarded when a dog has accumulated a given number of points. For additional detail, please refer to AKC Regulations for Lure Coursing Tests and Trials, Chapter XVI.

Gasoline powered continuous loop lure machine will be used; backup equipment will be available. Lure will consist of white plastic strips. Timing device is a break-the-beam electric timer which will show the recorded time for the dog. Stopwatches will be used in the event the electric timer is not functioning. If stopwatches are used, there will be two timers at the finish line and the times from the stopwatches is averaged to determine the recorded time. Run area is fully enclosed with entry and exit gates.

Trial Information

- Dogs should be warmed up before and cooled down after running.
- ALL DOGS RUN AT OWNER'S SOLE RISK
- All AKC rules regarding sportsmanship and conduct apply.
- This is a **rain-or-shine outdoor** event. Please plan accordingly.
- The FAST CAT chut is completely fenced in with entry and exit gates.
- On site porta johns are available.
- Dogs must be on lead or crated unless running.
- A fine will be assessed for any loose dog on the field not competing, or an exhibitor caught not picking up after their dog.
- You are responsible for controlling your dog(s) and children.
- The Hunt master is responsible for field safety and therefore he/she is in complete charge of all dogs and handlers on the field. He/She has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Persons exhibiting conduct detrimental to any dog(s) or person(s) will be asked to leave the site by the Field Committee, maybe disciplined by the AKC, and entry fees will not be refunded.

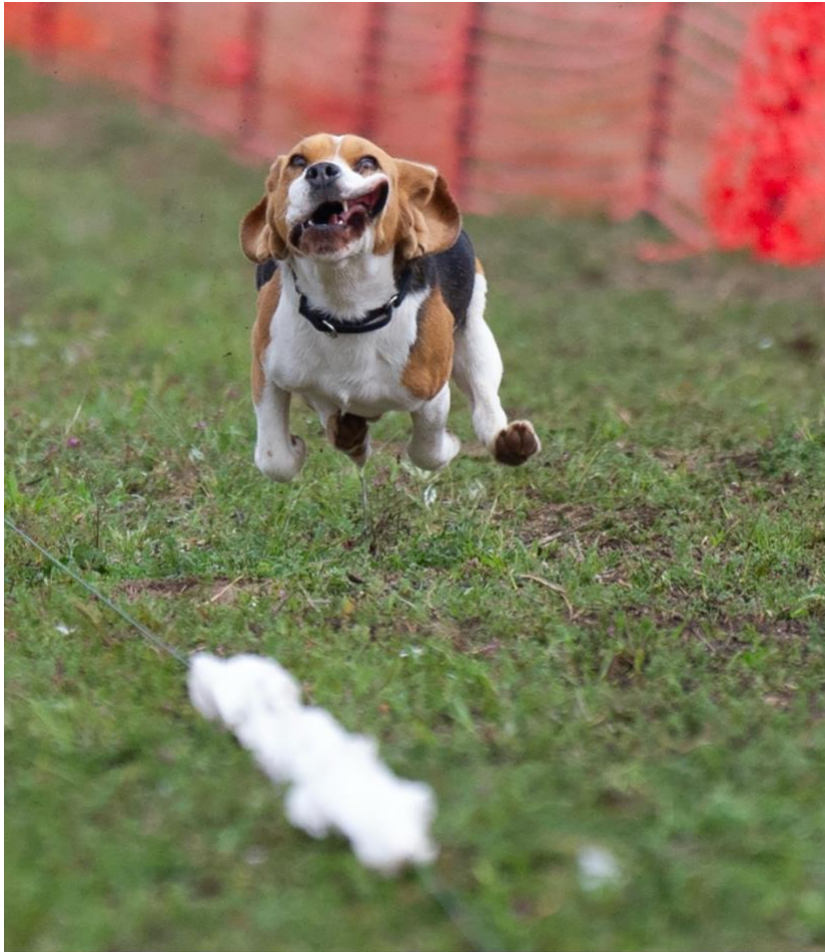
